Rating Rationale

Acuité has downgraded the long-term rating to 'ACUITE B (read as ACUITE B)from 'ACUITE B+' (read as ACUITE B plus) and reaffirmed the short-term rating to 'ACUITE A4' (read as ACUITE A four) on the Rs.10.78 crore bank facilities of Deccan Plast Industries (DPI) on account of information risk. The rating continues to be flagged as "Issuer Not-Cooperating" and is based on the best available information.

About the Company

Deccan Plast Industries (DPI) is a Mangalore based partnership firm established in 2010 by Mr. B H Asgar Ali, engaged in manufacturing of Plastic moulded furniture, Material handling plastic crates, House hold items. The firm's day to day operation was taken care by Mr. B H Asgar Ali.

Unsupported Rating Not Applicable

Non-cooperation by the issuer/borrower:

Acuité has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before the due date. Acuité believes that information risk is a critical component in such ratings, and non-cooperation by the issuer along with unwillingness to provide information could be a sign of potential deterioration in its overall credit quality. This rating is, therefore, being flagged as "Issuer not-cooperating", in line with prevailing SEBI regulations and Acuité's policies.
