Acuité has reviewed the long-term rating of '**ACUITE B+**' (read as **ACUITE B plus**) on the Rs.150.00 crore bank facilities of D. D. International Inc (DDI). This rating is now an indicative rating and is based on best available information.

The Haryana-based DDI incorporated in 1979 by Mr. Bhatia is engaged in the processing and trading of basmati rice and has an installed processing capacity of 27 tonnes per hour (TPH). The firm sells basmati rice under the brand name 'Nature's Gift'.

Non-cooperation by the issuer/borrower:

Acuité has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before due date.

This rating is therefore being flagged as "Issuer not-cooperating", in line with prevailing SEBI regulations and Acuité's policies.
