**The issuer did not co-operate; based on best available information.

Acuité has reviewed the long-term rating of '**ACUITE D**' (**read as ACUITE D**) on the Rs.13.50 crore bank facilities of Kunal Rice Mills (KRM). This rating is now an indicative rating and is based on best available information.

The Punjab-based, KRM was established in 2001 by Mr. Ukesh Julka. The firm has been in the rice milling (basmati) business for almost two decades. The milling unit, located at Qadian (Punjab), has an installed capacity of 9 tons per hour.

Non-cooperation by the issuer/borrower:

Acuité has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before due date.

This rating is therefore being flagged as "Issuer not-cooperating", in line with prevailing SEBI regulations and Acuité's policies.
