Rating Rationale

Acuite has reaffirmed the long-term rating of ‘**ACUITE D**’ (read as **ACUITE D**) on the Rs.13.50 crore bank facilities of Kunal Rice Mills (KRM). The rating continues to be flagged as “Issuer Not-Cooperating” and is based on the best available information.

About the Company

The Punjab-based, Kunal Rice Mills was established in 2001 by Mr. Ukesh Julka. The firm has been in the rice milling (basmati) business for almost two decades. The milling unit, located at Qadian (Punjab), has an installed capacity of 9 tons per hour.

Non-cooperation by the issuer/borrower:

Acuite has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before the due date. Acuite believes that information risk is a critical component in such ratings, and non-cooperation by the issuer along with unwillingness to provide information could be a sign of potential deterioration in its overall credit quality.

This rating is, therefore, being flagged as “Issuer not-cooperating”, in line with prevailing SEBI regulations and Acuite’s policies.
