Rating Rationale

Acuite has reaffirmed the long term rating of ‘**ACUITE D**’ (read as **ACUITE D**) and the short term rating of ‘**ACUITE D**’ (read as **ACUITE D**) on the Rs. 15.94 crore bank facilities of Shreebhav Polyweaves Private Limited. The rating continues to be flagged as “Issuer Not-Cooperating” and is based on the best available information.

About the Company

Shreebhav Polyweaves Private Limited (SPPL), incorporated in 2005, is a Surat-based company owned by Mr. Sanjay Agarwal and Mrs. Shalini Agarwal. The company manufactures fabric and undertakes embroidery job work.

Non-cooperation by the issuer/borrower:

Acuite has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before the due date. Acuite believes that information risk is a critical component in such ratings, and non-cooperation by the issuer along with unwillingness to provide information could be a sign of potential deterioration in its overall credit quality. This rating is, therefore, being flagged as “Issuer not-cooperating”, in line with prevailing SEBI regulations and Acuite’s policies.
