SMERA has reviewed the long term rating of '**SMERA B-**' (read as **SMERA b minus**) and short term rating of '**SMERA A4**' (read as **SMERA A four**) on the Rs.9.75 crore bank facilities of Malpani Veneers Private Limited (MVPL). This rating is now an indicative rating and is based on best available information.

**Non-cooperation by the issuer/borrower:** SMERA has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before due date.

This rating is therefore being flagged as "Issuer not-cooperating", in line with prevailing SEBI regulations and SMERA's policies.

**About the Rated Entity:** The Gujarat-based MVPL incorporated in 1997 by Mr. Malpani is engaged in the manufacture of veneer at Kutch, Gujarat.

For FY2014-15, the company reported net profit of Rs.0.14 crore on operating income of Rs.9.60 crore, as compared with profit after tax (PAT) of Rs.0.03 crore on operating income of Rs.17.85 crore in FY2013-14. For FY2015-16, the company booked revenue of Rs.7.20 crore (provisional). The net worth stood at Rs.2.46 crore as on March 31, 2015 as against Rs.3.79 crore a year earlier.
