For FY2013-14, ATCPL reported profit after tax (PAT) of Rs.1.10 crore on operating income of Rs.109.379 crore, as compared with profit after tax (PAT) of Rs.1.60 crore on operating income of Rs.88.44 crore in FY2012-13. ATCPL's net worth stood at Rs.7.41 crore as on March 31, 2014, as compared with Rs.6.31 crore a year earlier.
