SMERA has suspended the above mentioned rating of Goel Minerals & Chemicals (GMC). The suspension follows SMERA's inability to undertake rating surveillance in the absence of requisite information from the firm.

GMC established in 1976, is a Delhi-based proprietorship firm promoted by Mr. S.K. Goel. GMC is engaged in the trading of polymers.

For FY2013-14, GMC reported profit after tax (PAT) of Rs.2.80 crore on operating income of Rs.105.31 crore, as compared with profit after tax (PAT) of Rs.2.82 crore on operating income of Rs.101.69 crore in FY2012-13. The net worth stood at Rs.11.43 crore as on March 31, 2014 against Rs.8.73 crore a year earlier. GMC registered revenue of Rs.204.31 crore (provisional) in FY2014-15.
