PVAPL, incorporated in 2010, is a Chennai-based distributor of QSC Audio, Audio Technica, TOA, Auro 3D, Link & Eurocable, Luis WaSSmann and Klipsch. PVAPL is promoted by Mr. Natarajan Purushothaman and Mrs. Maheshwari Natarajan. The company has pan-India presence.

For FY2013-14, PVAPL reported net profit of Rs.0.41 crore on net sales of Rs.34.19 crore, as compared with net profit of Rs.0.40 crore on net sales of Rs.33.44 crore in FY 2012-13. The company registered net sales of Rs.34.20 crore (provisional) during April 2014 to February 2015. The net worth stood at Rs.4.76 crore as on March 31, 2014, as compared with Rs.4.34 crore a year earlier.
