Acuité has downgraded the long term rating to '**ACUITE BB**' (**read as ACUITE double B**) from '**ACUITE BB+**' (**read as ACUITE double B plus**) and reviewed the short-term rating of '**ACUITE A4+**' (**read as ACUITE A four plus**) on the Rs. 17.44 crore bank facilities of Adani Pharmachem Private Limited. The rating continues to be flagged as "Issuer Not-Cooperating" and is downgraded on account of information risk.

APPL (the erstwhile Adani Pharmachem), promoted by Harshadbhai Anantray Adani, Rushabh Hareshbhai Adani, Nirali Rushabh Adani was established in 1981. The company undertakes manufacturing and export of bulk drugs and fine chemicals. It derives ~37 per cent revenue from exports to Germany, Europe, Vietnam, and Brazil among others. The manufacturing unit is located at Rajkot, Gujarat.

#### Non-cooperation by the issuer/borrower:

Acuité has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before the due date.

This rating continues to be flagged as "Issuer not-cooperating", in line with prevailing SEBI regulations and Acuité's policies.
