Acuité has reviewed long-term rating of '**ACUITE BBB-**' (**read as ACUITE triple B minus**) and short term rating of '**ACUITE A3**' (**read as ACUITE A three**) on the Rs. 22.00 crore bank facilities of Chemcon Speciality Chemicals Private Limited (CSCPL). This rating is now an indicative rating and is based on best available information.

CSCPL, incorporated in 1988, is a Vadodara-based company engaged in the manufacturing of pharmaceutical intermediates, silicones and oilfield chemicals (completion fluids).

Non-cooperation by the issuer/borrower

Acuité has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer / borrower failed to submit such information before due date.

This rating is therefore being flagged as "Issuer not-cooperating", in line with prevailing SEBI regulations and Acuité's policies.
