SMERA has reviewed the long-term rating of '**SMERA D' (read as SMERA D)** on the Rs.11.00 crore bank facilities of Boss Computers Private Limited (BCPL). This is an indicative rating.

Non-cooperation by the issuer/borrower: SMERA has been requesting for data, information and undertakings from the rated entity for conducting surveillance and review of the rating. However, the issuer/borrower failed to submit required documents before due date.

This rating is therefore being flagged as "Issuer not-cooperating", in line with prevailing SEBI regulations and SMERA's policies.

About the rated entity: BCPL, incorporated in 2008, is a Chandigarh-based company promoted by Mr. Narinder Pal Singh. The company is involved in the business of computer hardware.

For FY2013-14, BCPL reported profit after tax (PAT) of Rs.0.42 crore on an operating income of Rs.22.38 crore, as compared with PAT of Rs.0.30 crore on an operating income of Rs.20.47 crore in FY2012-13. The company's net worth stood at Rs.6.29 crore as on March 31, 2014, as compared with Rs.6.47 crore a year earlier.
