Acuité has downgraded the long-term rating to 'ACUITE B+ (read as ACUITE B plus)from 'ACUITE BB-' (read as ACUITE double B minus) and the short-term rating to 'ACUITE A4' (read as ACUITE A four) from 'ACUITE A4+' (read as ACUITE A four plus)on the Rs. 34.50 crore bank facilities of Cee Dee Vacuum Equipment Private Limited on account of information risk. The rating continues to be flagged as "Issuer Not-Cooperating" and is based on the best available information.

Cee Dee Vacuum Equipment Private Limited, incorporated in 1988, is a Pune-based company promoted by Mr. Suhas Sopanrao Dhamle and Mr. Nitin Sopanrao Dhamle. The company undertakes designing and manufacturing of oil purification systems in Pune.
