Rating Rationale

Acuité has reaffirmed the long-term rating of 'ACUITE D' (read as ACUITE Do)n the Rs. 29.00 crore bank facilities of Marino Food Products Private Limited (MFPPL). The rating continues to be flagged as "Issuer Not Cooperating" and is based on the best available information.

About the Company

The Hyderabad-based Marino Food Products Private Limited (MFPPL), incorporated in 2010, was promoted by Mr. Om Prakash Chhawnika and Mr. Vaibhav Chhawnika. The company commenced commercial operations in November 2015 to manufacture bakery and confectionary products such as biscuits, cookies, cupcakes among others and has an installed capacity of 45 tons per day.

Non-cooperation by the issuer/borrower:

Acuité has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating.
