Rating Rationale

Acuite has withdrawn long-term rating of '**ACUITE BB**' (read as **ACUITE double B**) and short-term rating of '**ACUITE A4+**' (read as **ACUITE A four plus**) on the Rs. 8.72 crore bank facilities of D F F TEXTILES.

DFFT, established in the year 2005, is a Coimbatore based partnership firm promoted by Mr. Earnest NavamonyChellaraj and Mrs. S. Roseline Earnest. The company is into manufacturing of cotton yarn, fabrics and trading of textile machinery.

Analytical Approach

Acuite has considered standalone business and financial risk profile of DFFT to arrive at the rating.
