Rating Rationale

Acuité has reaffirmed the short-term rating of 'ACUITE A4' (read as ACUITE A four) on the Rs. 15.00 crore bank facilities of Sartaj International. The rating continues to be flagged as "Issuer Not-Cooperating" and is based on the best available information.

About the Company

Sartaj International (SI) established in 1990, is a Gurgaon-based proprietorship firm promoted by Mr. Jasjit Singh Chhabra. The firm is engaged in the manufacturing and export of readymade garments at Gurgaon, with an installed capacity of ~9 lakh pieces per annum. SI procures raw material from Delhi and Uttar Pradesh and exports to Dubai, U.SA, Europe and South America.

Non-cooperation by the issuer/borrower:

Acuité has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before the due date.

This rating is, therefore, being flagged as "Issuer not-cooperating", in line with prevailing SEBI regulations and Acuité's policies.

Limitation regarding information availability:

The rating is based on information available from sources other than the issuer/borrower (in the absence of information provided by the issuer/borrower). Acuité endeavored to gather information about the entity/industry from the public domain.
