SMERA has reviewed long-term rating of '**SMERA D**' (read as **SMERA D**) on the Rs. 7.22 crore bank facilities of J.K Non Woven Bags Private Limited (JK). This is an indicative rating.

Non-cooperation by the issuer/borrower

SMERA has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer / borrower failed to submit such information before due date.

This rating is therefore being flagged as "Issuer not-cooperating", in line with prevailing SEBI regulations and SMERA's policies.

About the rated entity

JK, incorporated in June 2012, is a Surat-based company engaged in manufacturing of non-woven bags, bouffant caps and masks. The company commenced commercial operations in February 2013 at Surat, with installed capacity of 200 tonnes per month (for bags) and 1,00,000 pieces per day for surgical caps and masks.

For FY2015-16, JK reported profit after tax (PAT) of Rs.0.06 crore (Provisional) on operating income of Rs.18.63 crore as compared with PAT of Rs.0.03 crore on operating income of Rs.14.96 crore in FY2014-15.
