Rating Rationale

Acuite has reaffirmed the long-term rating of '**ACUITE D**' (read as **ACUITE D**) on the Rs. 7.22 crore bank facilities of J.K.Non Woven Bags Private Limited (JK). The rating continues to be flagged as "Issuer NotCooperating" and is based on the best available information.

About the Company

J.K.Non Woven Bags Private Limited (JK), incorporated in June 2012, is a Surat-based company promoted by Mafatlal Ambalal Patel and Bimal Chandrakant Bhatt engaged in manufacturing of non-woven bags, bouffant caps and masks. The company commenced commercial operations in February 2013 at Surat (Gujarat) with installed capacity of 200 tonnes per month (for bags) and 1,00,000 pieces per day for surgical caps and masks.

Non-cooperation by the issuer/borrower:

Acuite has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before the due date.

Acuite believes that information risk is a critical component in such ratings, and non-cooperation by the issuer along with unwillingness to provide information could be a sign of potential deterioration in its overall credit quality.

This rating is, therefore, being flagged as "Issuer not-cooperating", in line with prevailing SEBI regulations and Acuite's policies.

Limitation regarding information availability:

The rating is based on information available from sources other than the issuer/borrower (in the absence of information provided by the issuer/borrower). Acuite endeavored to gather information about the entity/industry from the public domain. Therefore, Acuite cautions lenders and investors regarding the use of such information, on which the indicative credit rating is based.
