About the Firm

TVH, established in 2004, is a Jaipur-based proprietorship firm engaged in civil construction. The firm also undertakes engineering, procurement and construction (EPC) projects and consultancy services in structural designing.

For FY2013–14, TVH reported profit after tax (PAT) of Rs.1.70 crore on operating income of Rs.23.00 crore, as compared with PAT of Rs.1.68 crore on operating income of Rs.20.10 crore in FY2012–13. The firm reported revenue of Rs.20.00 crore (provisional) during April 2014 to March 2015. TVH's net worth stood at Rs.6.51 crore as on March 31, 2014, as compared with Rs.6.48 crore a year earlier.
