# **Rating Rationale**

Acuité has reaffirmed the long-term rating of 'ACUITE D' (read as ACUITE D) and short term rating of 'ACUITE D' (read as ACUITE D) on the Rs. 24.33 crore bank facilities of Hindon Forge Private Limited (HFPL). The rating continues to be flagged as "Issuer Not Cooperating" and is based on the best available information.

Hindon Forge Private Limited (HFPL), incorporated in 1978, is a Ghaziabad-based company promoted by Mr. Rajesh Agarwal. The company is engaged in the production of forged products like flanges, crankshafts, forged rings, etc.

# Non-cooperation by the issuer/borrower:

Acuité has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before the due date.
