Acuite has reviewed long-term rating of '**ACUITE BBB-**' (read as **ACUITE triple B minus**) to the Rs. 5.92 crore bank facilities of BETEX INDIA LIMITED (BIL). This rating is now an indicative rating and is based on best available information.

BIL, incorporated in 1987, is engaged in dyeing and printing synthetic cloths on job work bases. The company is based in Surat (Gujarat). The company is promoted by Sumeet Industries Limited and Somani family.

Non-cooperation by the issuer/borrower

Acuite has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating vide emails on 13th March, 2019, 18th March, 2019 and 26th March, 2019. However, the issuer / borrower failed to submit such information before due date.

This rating is therefore being flagged as "Issuer not-cooperating", in line with prevailing SEBI regulations and Acuite's policies.
