Rating Rationale

Acuité has reaffirmed the long-term rating of '**ACUITE BB-' (read as ACUITE double B minus)** on the Rs.5.92 crore bank facilities of Betex India Limited (BIL). The rating continues to be an indicative rating and is based on the best available information.

About the Company

Betex India Limited, incorporated in 1987, is engaged in dyeing and printing synthetic cloths on job work bases. The company is based in Surat (Gujarat). The company is promoted by Sumeet Industries Limited and Somani family.

Non-cooperation by the issuer/borrower:

Acuité has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before the due date. Acuité believes that information risk is a critical component in such ratings, and noncooperation by the issuer along with unwillingness to provide information could be a sign of potential deterioration in its overall credit quality. This rating continues to be flagged as "Issuer not-cooperating", in line with prevailing SEBI regulations and Acuité's policies.

Limitation regarding information availability:

The rating is based on information available from sources other than the issuer/borrower (in the absence of information provided by the issuer/borrower). Acuité endeavored to gather information about the entity/industry from the public domain. Therefore, Acuité cautions lenders and investors regarding the use of such information, on which the indicative credit rating is based.
