## Rating Rationale

Acuite has reaffirmed the long-term rating of 'ACUITE B+' (read as ACUITE B Plus) on the Rs. 9.00 Crore bank facilities of Handloom Cottage Private Limited (HCPL). The rating continues to be flagged as "Issuer Not Cooperating" and is based on the best available information.

## Non-cooperation by the issuer/borrower:

Acuite has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before the due date.
