Kalco, established in 2007, is a Ghaziabad-based company promoted by Mr. Neeraj Singhal and Mrs. Preeti Singhal. Kalco is engaged in manufacturing of aluminium doors, windows, ventilators among others.

For FY2013-14, Kalco reported profit after tax (PAT) of Rs.0.17 crore on operating income of Rs.14.87 crore, as compared with PAT of Rs.0.14 crore on operating income of Rs.13.78 crore in the previous year. The company's net worth stood at Rs.3.32 crore as on March 31, 2014, as compared with Rs.2.91 crore a year earlier.
