Rating Rationale

Acuite has reaffirmed the long-term rating of '**ACUITE C**' (read as **ACUITE C**) on the Rs. 30.00 Cr. bank facilities of Rajhans Infratech Private Limited (RIPL). The rating continues to be flagged as "Issuer Not Co-operating" and is based on the best available information.

Non-cooperation by the issuer/borrower:

Acuite has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before the due date.
