SMERA has suspended the above mentioned ratings of Su Solartech Systems Private Limited (SSSPL). The suspension follows SMERA's inability to undertake rating surveillance in the absence of requisite information from the company.

#### About the Company

SSSPL, established in 1985, is a Chandigarh-based company engaged in the manufacturing of solar photovoltaic lighting systems, solar thermal water heating systems and small PV wind hybrid power generation systems. SSSPL is promoted by Mr. Harinder Jain and Santosh Rani Jian.

SSSPL reported profit after tax (PAT) of Rs.0.04 crore on operating income of Rs.6.06 crore for FY2013-14, as compared with PAT of Rs.0.24 crore on operating income of Rs.8.41 crore for FY2012-13. The company reported revenue of Rs.5.52 crore (Provisional) for the period April 2014 to March 2015. SSSPL's net worth stood at Rs. 1.98 crore as on March 31, 2014.
