Acuite has reviewed the long-term rating of '**ACUITE D**' (read as **ACUITE D**) to the Rs.30.32 crore bank facilities of Vishnuvardhan Paper Mills Private Limited (VPMPL). This rating is now an indicative rating and is based on best available information.

VPMPL, incorporated in 1984, is a Tamil-Nadu based company headed by Mr. G Raveendran and Mr. G R Vishnuvardan. The company is engaged in manufacturing of printing paper, tissue and newsprint with an installed capacity of 36,500 tonnes per annum.

Non-cooperation by the issuer/borrower:

Acuite has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before due date.

This rating is therefore being flagged as "Issuer not-cooperating", in line with prevailing SEBI regulations and Acuite's policies.
