Acuité has reviewed the long-term rating of '**ACUITE D**' (read as **ACUITE D**) and the short-term rating of '**ACUITE D**' (read as **ACUITE D**) on the Rs. 8.00 crore bank facilities of VHS Mechatronics Services Private Limited (VMSPL). The rating continues to be flagged as "Issuer Not-Cooperating" and is based on the best available information.

VMSPL, incorporated in 1996 by Mr. Sivaraman Nair Krishnaprasad and Mr. Krishnaprasad Sivakumar as founder directors in Chennai which is engaged in rendering Annual maintenance services and repair works of CNC cutting machines.

### Non-cooperation by the issuer/borrower:

Acuité has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before the due date.
