## Rating Rationale

Acuité has downgraded the long term rating to 'ACUITE B' (read as ACUITE B) from 'ACUITE B+' (read as ACUITE B plus) and reaffirmed the short term rating of 'ACUITE A4' (read as ACUITE A four) on the Rs. 20.00 crore bank facilities of Mahateja Rice Mills Private Limited on account of information risk. The rating continues to be flagged as "Issuer Not-Cooperating" and is based on best available information.

#### **About the Company**

Telangana based, Mahateja Rice Mills Private Limited was incorporated in 2002. The company is engaged in the processing and trading of rice. The company has set up a rice mill in Nalgonda district with an installed capacity of 70000 quintals per month. The directors, Mr. Narsimha Manchukonda and Mr. Kushaliah Bandaru have over three decades of experience in the rice milling industry.

#### Non-cooperation by the issuer/borrower:

Acuité has been requesting for data, information and undertakings from the rated entity for
