Rating Rationale

Acuite has reaffirmed the long-term rating of '**ACUITE B-**' (read as **ACUITE B minus**) and the Short-term rating of '**ACUITE A4**' (read as **ACUITE A four**) on the Rs. 9.90 crore bank facilities of G Nageswaran (GN). The rating continues to be flagged as "Issuer Not-Cooperating" and is based on the best available information.

About the Company

G Nageswaran (GN), established in 1985, is a Chennai-based proprietorship firm engaged in the civil construction business. The firm caters mainly to Tamil Nadu Public Works Department (TN PWD) and National Highway Authority of India (NHAI). The Promoter is MR G Nageswaran.

Non-cooperation by the issuer/borrower:

Acuite has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer / borrower failed to submit such information before the due date. Acuite believes that information risk is a critical component in such ratings, and noncooperation by the issuer along with an unwillingness to provide information could be a sign of potential deterioration in its overall credit quality.

Limitation regarding information availability:

The rating is based on information available from sources other than the issuer / borrower (in the absence of information provided by the issuer / borrower).
