Rating Rationale

Acuité has downgraded the long-term rating to 'ACUITE B' (read as ACUITE Bf)rom 'ACUITE B+' (read as ACUITE B plus) on the Rs. 5.60 crore bank facilities of Compact Spinners India Private Limited (CSIPL) on account of information risk. The rating continues to be flagged as "Issuer Not-Cooperating" and is based on the best available information.

About the Company

Compact Spinners India Private Limited (CSIPL) is a Dindigul based company established in the year 2004 by Mr. A. Chockalingam, Mrs. Neela Chockalingam, and Mr. Neela Chockalingam, among others. The company is engaged in the manufacture of cotton yarn of count ranging 40s to 60s which is used to manufacture fabric for readymade garments. The company's manufacturing unit is located at Dindigul district, Tamil Nadu with an installed capacity of 14,920 spindles. The company is on course to add further capacity of around 11,000 spindles along with humidification equipment which is expected to commence operations from March 2018. CSIPL has a client concentration in Maharashtra and procures raw material, i.e. cotton, from various traders located in Karnataka, Telangana and Maharashtra.
