Rating Rationale

Acuité has reviewed the long-term rating of '**ACUITE BBB-**' (**read as ACUITE Triple B minus**) and short term rating of '**ACUITE A3**' (**read as ACUITE A three**) on the Rs.14.00 crore bank facilities of Ekta Engineering Udyog Private Limited. This rating is now an indicative rating and is based on best available information.

Ekta Engineering Udyog Private Limited (EEUPL), incorporated in 1954, is a Delhi-based company promoted by Mr. Rehan Elahi, Mr. Anwar Elahi and Mr. Rehman Elahi. The company is engaged in the manufacturing of pressure cookers and cookware items. The installed capacity stands at 10,000 cookers per day.

Non-cooperation by the issuer/borrower: Acuité has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before due date.

This rating is therefore being flagged as "Issuer not-cooperating", in line with prevailing SEBI regulations and Acuité's policies.
