Rating Rationale

Acuite has reviewed the long-term rating of '**ACUITE D**' (read as **ACUITE B**) on the Rs. 9.80 crore bank facilities of Darshan Cotton Industries (DCI). This rating is now an indicative rating and is based on best available information.

Non-cooperation by the issuer/borrower:

Acuite has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before due date.
