Rating Rationale

Acuite has reaffirmed the long-term rating of '**ACUITE D**' (read as **ACUITE D**) on the Rs. 9.80 crore bank facilities of Darshan Cotton Industries (DCI). The rating continues to be flagged as "Issuer Not-Cooperating" and is based on the best available information.

About the Company

Darshan Cotton Industries (DCI) was established in 2011 by Mr. Digamber Rao, is Bhainsa based company engaged in ginning cotton. DCI has 36 gins with the production capacity of 500 quintals of cotton lint per day.

Non-cooperation by the issuer/borrower:

Acuite has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before the due date.
