Acuité has reviewed the long-term rating of '**ACUITE D**' (read as **ACUITE D**) on the Rs. 17.30 Crore bank facilities of A.P. Steels and Alloys (APSA). This rating is now an indicative rating and is based on best available information.

APSA was established as a partnership firm in 2007 and commenced operations in 2009. The firm is engaged in manufacturing of Iron Ingots in Trichy (Tamil Nadu). The company caters to the needs of its group entity, A.P. Steels.

Non-cooperation by the issuer/borrower:

Acuité has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before due date.

This rating is therefore being flagged as "Issuer not-cooperating", in line with prevailing SEBI regulations and Acuité's policies.
