Rating Rationale

Acuité has reaffirmed the long-term rating of 'ACUITE D' (read as ACUITE D) and the short term rating of 'ACUITE D' (read as ACUITE D) on the Rs. 17.30 crore bank facilities of A.P. Steels and Alloys (APSA). The rating continues to be flagged as "Issuer Not Co-operating" and is based on the best available information.

About the Company

A.P. Steels and Alloys (APSA) was established as a partnership firm in 2007 and commenced operations in 2009. The firm is engaged in manufacturing of Iron Ingots in Trichy (Tamil Nadu). The company caters to the needs of its group entity, A.P. Steels. The firm is manage by Mr. Purushotham, the chief executive officer of the firm.

Non-cooperation by the issuer/borrower:

Acuité has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before the due date.

Acuité believes that information risk is a critical component in such ratings, and non-cooperation by the issuer along with unwillingness to provide information could be a sign of potential deterioration in its overall credit quality.

This rating is, therefore, being flagged as "Issuer not co-operating", in line with prevailing SEBI regulations and Acuité's policies.

Limitation regarding information availability:

The rating is based on information available from sources other than the issuer/borrower (in the absence of information provided by the issuer/borrower). Acuité endeavored to gather information about the entity/industry from the public domain. Therefore, Acuité cautions lenders and investors regarding the use of such information, on which the indicative credit rating is based.
