Acuite has downgraded the long term rating to '**ACUITE BB**' (read as **ACUITE double B**) from '**ACUITE BB+**' (read as **ACUITE double B plus**) and review the short term rating of '**ACUITE A4+**' (Read as **ACUITE A four plus**) on the Rs.27.17 crore bank facilities of Baddi Foils Private Limited (BFPL). The rating continues to be flagged as "Issuer Not-Cooperating" and is downgraded on account of information risk.

BFPL, incorporated in 2005, is a Baddi (Himachal Pradesh) based company promoted by Mr. Sanjay Khurana and Mrs. Geeta Khullar. The company is engaged in the manufacture of Pharmacy medicine packaging material such as aluminium foils, aluminium ROPP caps and seals. The manufacturing capacity for Aluminium foil is 350 metric tons in per month and 2 crore of ROPP Caps per month.

Non-cooperation by the issuer/borrower:

Acuite has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before the due date.

This rating continues to be flagged as "Issuer not-cooperating", in line with prevailing SEBI regulations and Acuite's policies.
