Rating Rationale

Acuité has reaffirmed the long term rating of 'ACUITE B-'(read as ACUITE B minus) on the Rs. 9.42 crore bank facilities of Goombira Tea Company Limited (GTCL). The rating continues to be flagged as "Issuer Not Cooperating" and is based on the best available information.

About the Company

Guwahati based Goombira Tea Company Limited (GTCL), incorporated in 1962, is a wholly owned subsidiary of Barak Valley Cements Limited. Goombira Tea Company Limited is an Assambased company and at present company managed by Mr. Gaurav Tulshyan, Mr. Santosh Kumar Bajaj and Mr. Kamakhya Chamaria. Goombira Tea Company Limited is engaged in the cultivation and trading of tea, rubber and bamboo. The company has around 920 hectares for tea cultivation.

Non-cooperation by the issuer/borrower:

Acuité has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before the due date.

Acuité believes that information risk is a critical component in such ratings, and noncooperation by the issuer along with unwillingness to provide information could be a sign of potential deterioration in its overall credit quality.

This rating is, therefore, being flagged as "Issuer not-cooperating", in line with prevailing SEBI regulations and Acuité's policies.

Limitation regarding information availability:

The rating is based on information available from sources other than the issuer/borrower (in the absence of information provided by the issuer/borrower). Acuité endeavored to gather information about the entity/industry from the public domain. Therefore, Acuité cautions lenders and investors regarding the use of such information, on which the indicative credit rating is based.
