## Rating Rationale

Acuite has reaffirmed the long-term rating of '**ACUITE B-**' (read as **ACUITE B minus**) on the Rs. 9.42 crore bank facilities of Goombira Tea Company Limited (GTCL). The rating continues to be flagged as "Issuer Not-Cooperating" and is based on the best available information.

## About the Company

Guwahati based Goombira Tea Company Limited (GTCL), incorporated in 1962, is a wholly owned subsidiary of Barak Valley Cements Limited. Goombira Tea Company Limited is an Assam based company and at present company managed by Mr. Gaurav Tulshyan, Mr. Santosh Kumar Bajaj and Mr. Kamakhya Chamaria. Goombira Tea Company Limited is engaged in the cultivation and trading of tea, rubber and bamboo. The company has around 920 hectares for tea cultivation.

## Non-cooperation by the issuer/borrower:

Acuite has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before the due date.
