Rating Rationale

Acuite has reaffirmed the long-term rating of '**ACUITE B+**' (read as **ACUITE B plus**) on the Rs.7.10 crore bank facilities of Sasi Road Finishers & Engineering Contractors (SRFES). The rating continues to be flagged as "Issuer Not-Cooperating" and is based on the best available information.

Sasi Road Finishers & Engineering Contractors is a partnership firm established in 2006 by Mr. Sangeeth Kumar and Ms. Sasikala. The firm is registered as a Class I contractor with PWD, Tamil Nadu and is engaged in the construction of roads and buildings.

Non-cooperation by the issuer/borrower:

Acuite has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before the due date.
