SCPL, established in 2000, is a Delhi-based company engaged in the manufacturing of cartons. The company is headed by Mr. Vijay Bhaskar, Director, who has around 33 years of experience in the above mentioned business.

In FY2014-15, SCPL reported profit after tax of Rs.0.48 crore on net sales of Rs.17.03 crore, as compared to net loss of Rs.0.17 crore on net sales of Rs.13.21 crore in FY2013-14. The company's net worth stood at Rs.3.75 crore as on March 31, 2015.
