Acuité has downgraded the long term rating to '**ACUITE B+**' (read as **ACUITE B plus**) from '**ACUITE BB-**' (read as **ACUITE double B minus**) and reviewed the short-term rating of '**ACUITE A4**' (read as **ACUITE A four**) on the Rs.22.00 crore bank facilities of B. N. Sons (BNS). The rating continues to be flagged as "Issuer Not-Cooperating" and is downgraded on account of information risk.

Jaipur based BNS was established 1985, by Mr. Mayank Somani and Mr. Madan Mohan Somani. The firm is engaged in the business of manufacturing of sodium silicate and trading of iron ore and scrap since inception.

Non-cooperation by the issuer/borrower:

Acuité has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before the due date.

This rating continues to be flagged as "Issuer not-cooperating", in line with prevailing SEBI regulations and Acuité's policies.
