Acuité has reviewed the long-term rating of '**ACUITE BB**' (read as **ACUITE double B**) and short term rating of **ACUITE A4** (read as **ACUITE A four**) on the Rs. 6.46 Crore bank facilities of JPN Pharma Private Limited (JPPL). This rating is now an indicative rating and is based on best available information.

JPPL, a proprietary concern established in 1991 was converted into a Private Limited company in 2004 by promoter Directors, Mr. Mukund Popatlal Shah and Mr. Jayesh Popatlal Shah. The company is engaged in the manufacturing of active pharma ingredients (API) and intermediates.

Non-cooperation by the issuer/borrower:

Acuité has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before due date.

This rating is therefore being flagged as "Issuer not-cooperating", in line with prevailing SEBI regulations and Acuité's policies.
