Acuité has reviewed the long-term rating to '**ACUITE B-**' (**read as ACUITE B minus**) on the Rs.14.00 Cr bank facilities of Chandrawati Hospitality and Tourism (CHT). The rating continues to be flagged as "Issuer Not-Cooperating" and is based on the best available information.

The Bhartpur (Rajasthan) based, CHT, incorporated in 2010, is a partnership firm promoted by Dr. Jitendra Singh, Mrs. Beena Singh and Miss. Bijil Singh. The operations of the firm were about to commenced business from July 2015. However, delay in the commencement had been observed and expected time as per management was June 2017.

#### Non-cooperation by the issuer/borrower:

Acuité has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before the due date.

Acuité believes that information risk is a critical component in such ratings, and non-cooperation by the issuer along with unwillingness to provide information could be a sign of potential deterioration in its overall credit quality.

This rating continues to be flagged as "Issuer not-cooperating", in line with prevailing SEBI regulations and Acuité's policies.
