**The issuer did not co-operate; based on best available information.

Acuité has reviewed the long-term rating of '**ACUITE B**' (read as **ACUITE B**) and short term rating of '**ACUITE A4**' (read as **ACUITE A four**) on the Rs. 7.00 crore bank facilities of Kalinga Cables & Conduit Co (KCCC). This rating is now an indicative rating and is based on best available information.

KCCC, established in 2005, is a New Delhi-based partnership firm promoted by Mr. Rajiv Sethi and Mr. Sudhir Sethi. The firm is engaged in the manufacturing of power cables, single core industrial cables, PVC conduit and casing.

Non-cooperation by the issuer/borrower:

Acuité has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before due date.

This rating is therefore being flagged as "Issuer not-cooperating", in line with prevailing SEBI regulations and Acuité's policies.
