ABA IPL, incorporated in 2009, is a Hyderabad-based company promoted by Mr. K Radhakrishna Reddy and Mr. H Ananda Reddy. The company manufactures micro irrigation systems (drip and sprinkler irrigation) apart from high, low, linear-low density polyethylene and polyvinyl chloride pipes.

ABA IPL registered profit after tax (PAT) of Rs.0.06 crore on revenue of Rs.08.53 crore for FY2013-14, as compared with loss of Rs.0.13 crore on revenue of Rs.02.88 crore in FY2012-13. ABA IPL's net worth stood at Rs.1.63 crore as on March 31, 2014, as compared with Rs.0.87 crore a year earlier.
