**The issuer did not co-operate; based on best available information.

Acuité has reviewed the long-term rating of '**ACUITE B+** (read as **ACUITE B plus**) and short-term rating of '**ACUITE A4** (read as **ACUITE A four**) on the Rs.8.75 Cr bank facilities of Lesha Agencies (LA). The rating continues to be flagged as "Issuer Not-Cooperating" and is based on the best available information.

Established in 2004, LA, promoted by Mr. Kiran Jain is a proprietorship concern, engaged in the distribution of Micromax, Sony and Ziox smartphones as also satellite television equipment for TATA Sky in Pune.

Non-cooperation by the issuer/borrower:

Acuité has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before the due date.

Acuité believes that information risk is a critical component in such ratings, and non-cooperation by the issuer along with unwillingness to provide information could be a sign of potential deterioration in its overall credit quality.

This rating is, therefore, being flagged as "Issuer not-cooperating", in line with prevailing SEBI regulations and Acuité's policies.
