SMERA has reviewed the long term rating of '**SMERA BB**' (read as **SMERA Double B**) and short term rating of **SMERA A4+** (read as **SMERA A four plus**) on the above bank facilities of Ganesh Steel and Alloys Limited. Ganesh Steel and Alloys Limited, incorporated in 1995 is Kolkata based company promoted by Mr. S. K Nahata, Mr. N.K. Baid and Mr. N.M Baid. The company is engaged in manufacture of ingots at Hooghly, West Bengal and has an installed capacity of 35000 metric tonnes per annum.

For FY15-16, GASL reported profit after tax (PAT) of Rs.0.70 crore on operating income of Rs.50.28 crore, as compared with PAT of Rs.0.59 crore on operating income of Rs.64.68 crore for
