Rating Rationale

Acuité has downgraded the long-term rating to 'ACUITE B+' (read as ACUITE B plus) from 'ACUITE BB-' (read as ACUITE double B minus) on the Rs. 16.00 crore bank facilities of Shreenathii Gems and Jewels Private Limited(SGJPL) on account of information risk. The rating continues to be flagged as "Issuer Not-Cooperating" and is based on the best available information.

About the Company

Shreenathji Gems and Jewels Private Limited, incorporated in 2010, is a Mumbai-based company promoted by Mr. Sunil Dokania. It was incorporated to take over the business of Shreenathji Gems & Jewels, a proprietorship concern set-up in 2001. The company is engaged in the wholesale trading of plain gold jewellery. Shreenathji Gems and Jewels Private Limited outsources its manufacturing activity to units in Mumbai.

Non-cooperation by the issuer/borrower:

Acuité has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before the due date.
