Acuité has reviewed the long-term rating of '**ACUITE BB+**' (read as **ACUITE BB plus**) on the Rs. 24.20 crore bank facilities of Sambaragi Traders (ST). This rating is now an indicative rating and is based on best available information.

ST, established by Mr. S.V. Pattanshetti, commenced operations in 1973. The Company is headed by Mr. R.M. Sambaragi, Mr. B.S. Pattanshetti, Mr. Manish R. Sambaragi and others. The firm trades in Indian Made Foreign Liquor for United Spirits Limited and Daigeo India Private Limited and is the dealer in Kolhapur, Sangli, Ratnagiri and Sindhudurg regions.

Non-cooperation by the issuer/borrower:

Acuité has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before due date.

This rating is therefore being flagged as "Issuer not-cooperating", in line with prevailing SEBI regulations and Acuité's policies.
